Development Committee (Deb Swisher)

7. Publix Lighting (Cindy Bear)

Cindy Bear reported that Publix has been very responsive to the letter from GPICA requesting dimming of the lights for wildlife protection. The original letter went to Omar Singh, store manager. Since then Cindy Bear has been working with Alicia Leahey from the Publix Real Estate Dept at Lakeland Corporate office. Alicia is currently working with the engineers to review the development code to change the lighting to the east of the store. Cindy advised all lighting is a problem and was told that because the facility has a 24/7 ATM security lighting is required. Discussions are continuing.
